This quarterly e-bulletin covers CEHAT's work on Abortion, which includes Research, Advocacy and Campaigns. RESEARCH

In the area of Abortion CEHAT has done wide range of research in order to understand the issue of abortion, one of the first studies of CEHAT was undertaken to understand the politics of abortion and to place abortion in the larger context of women's rights. A qualitative study was undertaken to understand abortion from women's perspective which was carried out in rural Maharashtra. In continuation with the issue CEHAT also conducted a study of the abortion care facilities and providers in two districts of Maharashtra. The studies were focused on understanding abortion services provided at registered and non-registered, government and private abortion care facilities... Past studies

Under the Abortion Assessment Project-India (AAP-I) CEHAT and Health-watch has done a wide range of quantitative and qualitative studies looking at various dimensions of the abortion issues from profiling abortion services, quality of care, methods of abortion, cost of abortion services, decision making in abortion, sex selection, pregnancy outcomes, informal providers etc. were undertaken in 16 different states by 24 research institutions.

Under the AAP-I India project CEHAT also conducted a household study to study the pregnancy outcome analytically in the state of Maharashtra with a focus on abortion incidence, care received and costs incurred. The study aimed at providing inputs to society at large and to different stakeholders including policy makers to facilitate women's access to safe, legal and affordable abortion care <a href="mailto:services...National Abortion Assessment Project

ADVOCACY, EDUCATION & CAMPAIGN

CEHAT research gave advantages and make possible to interact extensively and in a focused manner with the two important communities, women and abortion service providers. Most of the advocacy efforts were in building awareness on abortion issues, identifying larger issues concerning improvement of the quality of abortion care services and their expansion, inviting state-level consultations to generate a discourse on them, lobbing with the concerned communities, and advocating legislative amendments which would facilitate the procedure of MTP registration.

Under the AAP-I project dissemination and advocacy strategy state level consultations were organised covering 23 states where findings of the research were disseminated and issues for advocacy were evolved - state level consultations were organised in Orissa, Rajasthan, Uttar Pradesh, Bihar, Jharkhand, Madhya Pradesh, Assam and other North East states, West Bengal, Delhi, Kerala, Tamilnadu, Karnataka, Gujarat, Himachal Pradesh, Maharashtra, Andhra Pradesh, Punjab, Haryana, with the help of nodal agencies in the respective states. These meetings were attended by state level officials from the Health and Family Welfare departments, medical professionals from the public and private sectors, NGOs, activists, representatives of medical associations like the Federation of Obstetrics and Gynecological Society of India (FOGSI) and Indian Medical Association (IMA) and the academia and media. Various research study findings undertaken under the AAP-I were also widely disseminated. These meetings provided an opportunity for dialogue across various stakeholders and came up with issues and concerns for advocating the cause of abortion and other reproductive health issues within a rights based framework. . . Report of the State Level consultations

The present project aims to demonstrate the feasibility of providing safe and quality abortion services at all levels through service delivery and communication interventions in two states. It also facilitates effective implementation of the law and existing policies across the two states and will

address policy and advocacy issues at the state and national level on abortion rights. The present project is being implemented by a consortium for safe abortions in India consisting of ARTH, CEHAT, FOGSI, FPA India, IMCH-Uppsala University, IPAS and Population Council. . . : Atmajaa: Born from the soul: Female foeticide is the single most important cause of the alarming decline in the sex ratio, 'Atmajaa' tries to understand the reasons why both, educated well off people and those from economically challenged sections continue to prefer boys to girls. This is done by studying the pressures on Ruchi Munjal the daughter-in-law of the rich Munjal household and Urmilla the maid, to go in for medical termination of their pregnancies when both of them have conceived girls. : MTP Act ... 30 years later (Marathi & English): About the abortion assessment in Maharashtra State. Nearly 30 years later, the law and associated rules and regulations are considered overly medicalised and bureaucratic, and as such, not oriented towards women's right to access safe and legal abortion services.

- Sex selective abortion Kutch dil se: The Monday to Thursday talk show on Sab TV at 2.30 p.m. hosted by Smriti Irani revolves around social issues where lawyers, cops, psychiatrists, doctors, social workers and celebrities answer viewer queries. This is a recording of one episode, which is on Sex Determination.
- : Cheekh (Hindi): Sex selective abortion: Cheekh is a documentary prepared by Garbhastha Shishu Sanrakshan Samiti, who highlights some issues which are related to Sex discrimination & Abortion. It highlights some points related to Infant mortality also.
- : Sachetana: Implications of unsafe abortion's in Nepal: "SACHETANA" is a short educational film produced by CREHPA to bring awareness among the public about the implications of restrictive abortion law on women's reproductive health and their social status. This educational film is in Nepali and has English sub-titles. The film is based on research studies conducted by CREHPA in prisons and selected hospitals of Nepal.
- : Manual vacuum aspiration: A new gold standard for first trimester abortion: MVA is the single most promising procedure with the potential for generating and increasing access to safe abortion in every corner of India, with immediate & measurable benefits on women's health & well-being.
